C. <u>Details of Terms & conditions</u>:

Sealed quotation from ICCR empanelled agencies are invited for Air/ Sea/ Surface freight alongwith lumpsumconsolidated charges inclusive of local transportation packing labour, insurance, agency handling, and all other component towards clearance for baggage at Cargo etc.in above weight category. Rate of Taxes / GST Rates chargeable may be quoted separately in the prescribed proforma attached.

Please note the following before submitting quotations: -

- 1) Routing with flight/ airlines details etc. should be mentioned.
- 2) Transit time should clearly be mentioned.
- 3) Only normal and cheapest rates should be quoted and not the express rates.
- 4) Quoted rates should be inclusive of all other misc. / incidental charges and in rupees per kg, except that the tax/GST Rates may be mentioned separately in the prescribed column of the proforma.
- 5. Cargo Insurance details to be specifically mentioned.
- Sealed quotations should be deposited in a sealed Box placed at the Reception of the ICCR by the last date & time as stipulated in the NIT.
- Quotations received through other modes such as post, email or hand over to individual official of ICCR will be rejected.
- 8) Cargo weight mentioned above is a maximum eligibility limit of an officer, which may vary on case to case basis and payment will be settled only on actual weight basis in per kg. rate subject to maximum limit.
- 9) Successful bidder will have to accept the offer of ICCR in writing and need to enter in an agreement with ICCR as per the terms & conditions laid down in NIT.
