The Earnest Money Deposited shall not bear any interest. The EMD of unsuccessful bidders shall be returned within one month from the auction date, without any interest.
- The bidders may inspect the staff cars at the address where the cars are auctioned and satisfy themselves about the staff cars they are bidding for, the details of Contact Persons mentioned in the EMD table (page no.01).
- 3. The staff cars shall be sold to the highest bidder.

- 4. No staff car, once disposed to the successful bidder, shall be taken back by O/o ICCR.
- 5. The successful bidder has to make full balance payment in the form of Demand Draft/Pay order in favour of ICCR payable at respective stations within 3 working days of the receipt of the communication to this effect from this office, failing which the offer will be cancelled and EMD shall stand forfeited.

The successful bidder will have to take delivery of the vehicle within three working days of acceptance of this bid after making the payment of the quoted amount (EMD amount will be adjusted with the quoted value) and submission of affidavit, failing which the successfully bidder will forfeit his right over the vehicle and process will be initiated for handling over the vehicle to the second lowest bidder or cancellation of the bid process.
