2. Scope of Work

4. Terms and Conditions –

- (i) Mere submission of the proposal, shall not confer any right whatsoever on the submitting entity.
- (ii) The proposal shall remain valid for a period of one year from the date of publication of RFP.
- (iii) It shall be obligatory on part of the submitting entity to furnish any further information as may be sought by ICCR.
- (iv) Each page of the Proposal must be self attested by bidder.
- (v) Neither the issue of this notice nor any part of its contents are to be taken as any form of commitment or acknowledgement on part of ICCR to proceed with any proposal or any entity.
