Please note the following points before sending the quotation:-

1. Routing with flight/airlines details etc. should be mentioned
2. Only ICCR empanelled Shipping & Clearing Agencies may be entertained.

3. Transit time should also be mentioned.
4. Quoted rates should be inclusive of all taxes, Air-freighting /Transportation/ Labour/packaging/insurance/ handling agency charges etc, as per given format:-
