ICCR invites tender for commissioning of Bust for installation abroad, as per details given below :

2. Scope of Work:-

A bust of Kasturba Gandhi Commissioning of statue as per the following details/ specification / dimensions with proposer packing for sending through air /sea cargo for installation in Durban, South Africa–

i.	Size: (to be filled)	35 inches
ii.	Details of plaque / description beneath the installation	Bust of Kasturba Gandhi
iii.	Material	Copper 85%, Tin 5%, Zinc 5%, Lead 5%
iv.	Minimum Weight:	Approximately 80- 150 Kgs (without packing)
v.	Packing:	Wooden packing as per international standard for air cargo/sea cargo
vi.	Name of the country	Durban, South Africa

3. Eligibility Criteria:-

- i. Atleast 3 years experience in making bronze statues / busts
- ii. Should have GST / PAN Number
- iii. Should have done commissioning in foreign countries
- iv. Should have worked /commissioned busts/statues which are installed by Govt. of India/State Government.
- v. Quotation of rate (in INR) is compulsory.
- vi. Should have not be barred /blacklisted by any government/autonomous /statutory body of India.
- vii. Providing last 3 years of ITR.



4. Terms and Condition:-

i.	Mere submission of the proposal shall not confer any right whatsoever on the submitting entity.
ii.	The proposal shall remain valid 04.10.2024 from the date of publication RFP.
iii.	It shall be obligatory on part of the submitting entity to furnish any further information as may be sought by ICCR.
iv.	Each page of the Proposal must be self attested by the bidder.
v.	Neither the issue of this notice nor any part of its contents are to be taken as any form of commitment or acknowledgement of part of ICCR to proceed with any proposal or any entity. ICCR reserves the right to annual or terminate the process, project or reject any proposal at any time or at any stage without assigning any reason.
vi.	No amendments / changes will be allowed after submission of bids.
Vii	Payment will be made only after successfully delivery of the statue to Indian Mission.
Viii	Payment to bidder by way of compensation or otherwise outside the terms of the contract or in excess of the contract rate will not be allowed under any circumstances.
ix	Successful bidders will be required to provide the bust / statue within a period of 15 days from the award of contract, failing which the ICCR reserves its rights to cancel the contract without any compensation whatsoever.
X	Pre-dispatch examination of the final product will be conducted by the person(s) authorize by ICCR.
Xi	Successful bidders will submit Certificate of Authentication from SISI (Small Industries Service Institute,Okhla) certifying the material used in the artwork
Xii	Successful bidders will submit Undertaking transferring the ownership right, copyright, intellectual property right to ICCR for that particular artwork which has been commissioned for ICCR.

5. Penalty Clause

- (a) Failure to supply the material within stipulated period shall be result of penalty 0.5% (Half percent) of the total value of the item per day subject to a max. of 5% (five percent) unless extension is given to the firm.
- (b) In case the size/specifications of artwork does not match the requirement, the amount incurred by ICCR/Mission to repair/redo the size of pedestal will be deducted from the bill amount.
